This Agreement is by and between Ashley's Canine Training Corp. (hereinafter called "Trainer") and the dog owner whose name and signature appears below (hereinafter called "Owner"). Following are the terms of service:

1. During the training program, Trainer will provide an individual suite space at The Barkley Pet Hotel & Day Spa ("The Barkley"), located at 27349 Miles Road, Orange Village, Ohio 44022. During such time, Trainer shall take due and reasonable care to maintain a safe, clean, and secure environment and to feed and medicate as directed by the Owner. Owner releases Trainer from any claims made against Trainer or The Barkley or either parties' employees, members or other agents or losses or damages of any kind suffered by The Barkley for or, attributable to, any injury or illness of dog. Owner agrees that Owner shall be solely responsible for any and all acts and behavior of said dog while in the care of The Barkley, including payment of costs for injury to staff or other animals or damage to facilities caused by the dog.
2. The dog will be trained at the Owner's request and as shown in demonstration. Included in training are private sessions with the Owner. Owner understands and agrees that should Owner fail to attend and cooperate fully during these training sessions, Trainer does not assume or accept responsibility for the behavior or performance of the dog after it has returned to the Owner.
3. If during training Trainer feels the dog is ill or not up to training, Owner may decide to resume training at a later date for no additional charge exceeding original contract price. If any delay or interruption of training occurs causing a delay at our request there will be no additional charge to Owner. This includes delays for stress, which may show up during training.
4. If during training dog shows signs of a medical problem, Owner authorizes Trainer and/or The Barkley to obtain medical attention for dog from any qualified veterinarian and to transport Pet to and from that veterinarian when Trainer and/or The Barkley deems such medical care is important to dog's health. Owner grants to Trainer and/or The Barkley or its employees or agent's full power of decision-making involving the medical treatment of Pet and agrees to pay for all costs. This applies to any claims for injuries or damages related to such medical care or transport.
5. Trainer or The Barkley is not liable for loss or damage to the dog or owner's other property resulting from fire, disease, illness, virus, escape, theft, death or other unavoidable causes. After the dog has been returned to the Owner, Trainer does not accept any responsibility for the injury, illness, or death of the dog or of any person or animal or damage to any property, caused by the dog.
6. Owner represents that owner is the legal owner of the dog; that the dog is free and clear of any mortgage or other encumbrance; that the dog has not been exposed to Distemper, Rabies, or Parvo within the past thirty days; that the dog has been inoculated as shown above; that the dog is currently and properly licensed; and that the owner has read this Agreement to its entirety.
7. Owner acknowledges and is aware that the Trainer and the employees of The Barkley are not veterinarians and do not have backgrounds in animal medicine and are not expected to diagnose or detect illnesses in the pets that are staying at The Barkley. In addition, Owner acknowledges and is aware that no amount of supervision, sanitation or personalized care can prevent a pet from contracting an airborne virus or communicable disease. Despite these precautions, Owner understands that Owner releases Trainer and/or The Barkley from, and waives all claims and liability against Trainer and/or The Barkley for, all losses, damages, costs and expenses arising out of or in connection with any communicable disease, airborne virus, or any other medical disease contracted by dog at The Barkley.
